Public Notice is hereby given that the Regional Council of the Southern California Association of Governments (SCAG) is conducting a public hearing to consider adoption of the 5<sup>th</sup> Cycle Final Regional Housing Needs Allocation Plan at the date, time, and location identified above. This public hearing signals the end of SCAG's 5th Cycle of the RHNA process to issue the Regional Housing Need Allocation Plan required by the State of California in order for local jurisdictions to prepare updated General Plan Housing Elements.

The 5th Cycle Final RHNA Plan has been prepared in accordance with applicable provisions of Government Code Section 65580 et seq. and maintains a total regional housing need, by income category, within the range determined by the State of California Department of Housing and Community Development on August 17, 2011.
