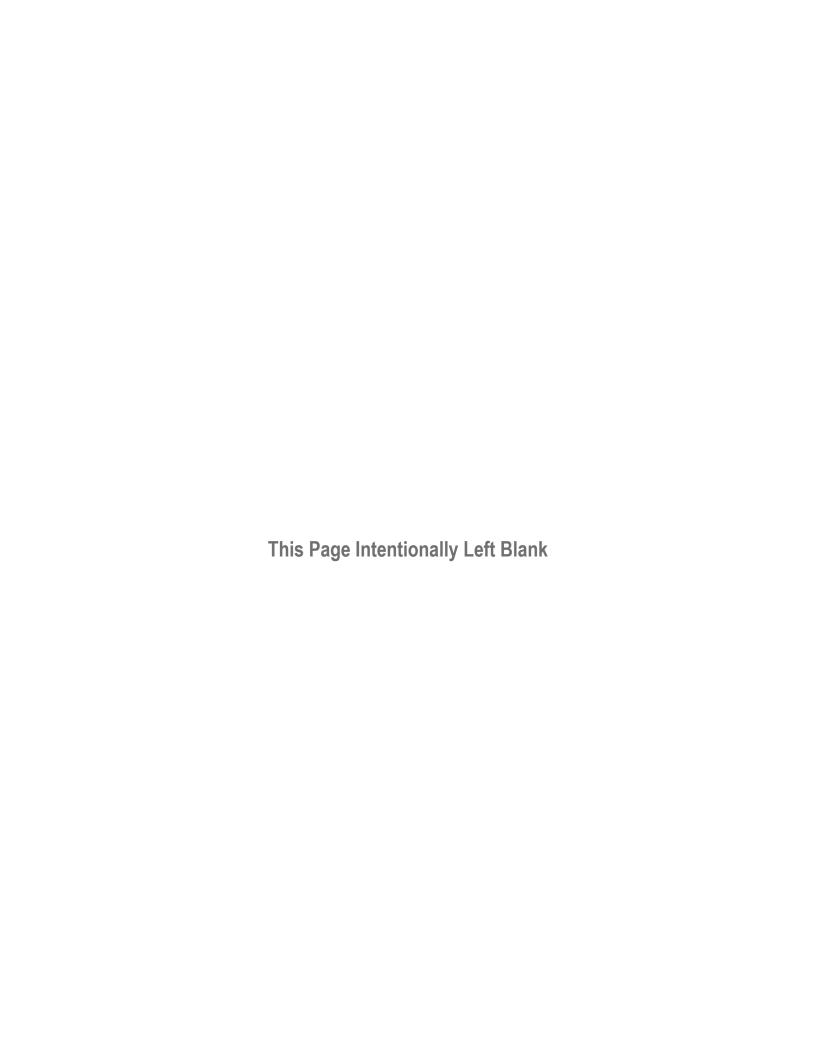

#### **INFORMATION ITEMS**

7. <u>Draft Local Input Survey for the 2020 Regional Transportation Plan/Sustainable</u> Communities Strategy (RTP/SCS)

Roland OK, SCAG staff, stated that SCAG is developing a Local Input Survey to collect information from local jurisdictions related to the implementation of the 2012 and 2016 RTP/SCS and assist in the development of the 2020 RTP/SCS. Survey questions are wide-ranging in scope, but focused on developing a meaningful summary of where the region currently stands, and where regional sustainability priorities might best be focused in the next RTP/SCS. Upon finalization, the Local Input Survey will be distributed to all local jurisdictions. Information collected from the survey will facilitate the Local Input Process and assist in developing a robust 2020 RTP/SCS.

8. The Challenges of Homelessness and Strategies for Local Jurisdictions

Phil Ansell, Director of the County of Los Angeles Office of Homeless Initiative, presented the challenges of homelessness and the strategies that the County of Los Angeles has undertaken to address the issue. Local jurisdictions face increasing challenges, particularly as the housing crisis worsens. Mr. Ansell stated there are over 69,000 homeless individuals in the SCAG region and

almost 60,000 are in Los Angeles County. Over 70 percent are unsheltered in the SCAG region. Mr. Ansell outlined strategies that jurisdictions may utilize to address homelessness locally.

#### **CHAIR'S REPORT**

The Chair reported that the encore Strike Team was in Sacramento on August 30, 2017 to address the housing package and Cap-and-Trade regional equity. The Chair also reminded the Committee members that SCAG is hosting its 8<sup>th</sup> Annual Economic Summit on November 9, 2017.

There was no staff report presented.

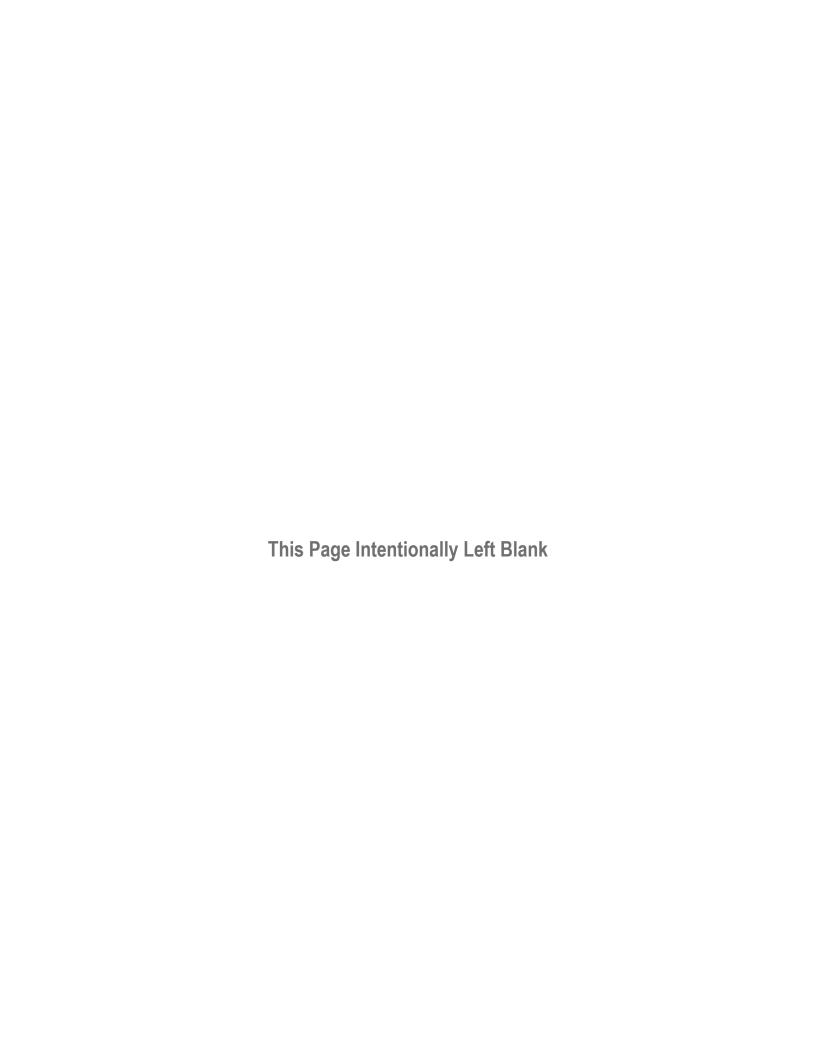

#### **EXECUTIVE SUMMARY:**

"Walktober" is a month-long international campaign designed to inspire everyone to make walking a priority during the month of October. "Walktober" expands the goals and strategies associated with International Walk to School Day, a global event that involves communities from more than 40 countries walking and biking to school on the same day in October. Started in 1997, the one-day, annual event has become part of a movement for year-round safe routes to school and is celebrated each October. The 2016 Regional Transportation Plan and Sustainable Communities Strategy supports increased rates of active transportation. Staff is conducting activities throughout Walktober to support these efforts.

#### **STRATEGIC PLAN:**

This item supports SCAG's Strategic Plan, Goal 1 (Improve Regional Decision Making by Providing Leadership and Consensus Building on Key Plans and Policies), Objective a (Create and facilitate a collaborative and cooperative environment to produce forward thinking regional plans).

#### **BACKGROUND:**

The 2016 Regional Transportation Plan and Sustainable Communities Strategy (RTP/SCS) seeks to "Protect the environment and health of our residents by improving air quality and encouraging active transportation (e.g., bicycling and walking)." To do this the Active Transportation Appendix lays out a series of strategies aimed at increasing rates of walking and bicycling including working with county agencies to "Establish Safe Routes to School policies for the region."

This item is being presented to inform SCAG Policy Members of "Walktober" activities occurring during the month of October 2017.

Go Human, SCAG's active transportation safety and encouragement community outreach campaign, aims to reduce traffic collisions in Southern California and encourages people to walk and bike more. The campaign provides advertising and educational resources to partners and implements temporary safety demonstration projects to showcase innovative transportation designs and help cities re-envision their streets as safer, more accessible places for walking and biking. Campaign staff will partner with stakeholders across the region to execute activities throughout "Walktober" to support safety and encouragement goals.



On October 1, 2017, Go Human will partner with the City of Santa Monica's "COAST Open Streets Festival (event information and map available at <a href="https://beta.smgov.net/strategic-goals/mobility/coast">https://beta.smgov.net/strategic-goals/mobility/coast</a>). The two mile corridor opens the streets to people walking and biking. Go Human will conduct education and outreach to participants.

On October 4<sup>th</sup>, Go Human's partners at the Riverside University Health System Department of Public Health will host International Walk to School Day in Riverside County. The Riverside Safe Routes to School team has goals to reach 100 schools countywide to participate. Go Human has contributed materials for schools and agencies across Riverside County, including lawn signs with safety messaging.

Go Human will also partner with CicLAvia and the City of Los Angeles on October 8<sup>th</sup> to showcase walking and biking improvements alongside and adjacent to the open streets corridor (event information and map available at <a href="http://www.ciclavia.org/">http://www.ciclavia.org/</a>). With CicLAvia's regional reach, Go Human will demonstrate a protected bike lane and place-making elements in downtown Los Angeles as part of the City's Vision Zero initiative.

Finally, on October 21<sup>st</sup>, Go Human will partner with Orange County Public Works and the cities of Westminster, Garden Grove and Santa Ana to host "Redefine Hazard Avenue" in Orange County. The event will demonstrate a bike lane project along Hazard Avenue, spanning three cities. The corridor provides important access to destinations like schools and business for the surrounding community. **SUBJECT:** SB 1 Sustainable Communities Planning Grant Programs

#### **EXECUTIVE SUMMARY:**

On September 14, 2017, the California Department of Transportation (Caltrans) released its Final SB 1 Grant Guide and a Call for Applications for Sustainable Communities Planning and Climate Adaptation Grants for FY 17-18. Sustainable Communities Planning Grants will fund a total \$25 million in transportation and land use planning projects that further an MPO's RTP/SCS, and contribute to the State's GHG reduction targets. Additionally, \$7 million of SB1 Climate Adaptation Grant funds will be awarded on a competitive basis to support planning actions at local and regional levels that advance climate change adaptation efforts on the transportation system.

#### **STRATEGIC PLAN:**

This item supports SCAG Regional Goal 1) Improve Regional Decision Making by Providing Leadership and Consensus Building on Key Plans and Policies, c) Provide practical solutions for moving new ideas forward

#### **BACKGROUND:**

Caltrans has released its Final SB 1 Grant Guide and a Call for Applications for Sustainable Communities Planning and Climate Adaptation Grants for FY 17-18. Sustainable Communities Planning Grants will fund a total \$25 million in transportation and land use planning projects that further an MPO's RTP/SCS, and contribute to the State's GHG reduction targets. SCAG will receive over \$5 million in Sustainable Communities Planning formula funds to be used consistent with the Final Grant Guidelines. A total \$12.5 million in grant funds will be available on a competitive basis to non-MPO regional transportation planning agencies, transit agencies, cities, counties, and Native American Tribal Governments. Additionally, \$7 million of SB 1 Climate Adaptation Grant funds will be awarded on a competitive basis to support planning actions at local and regional levels that advance climate change adaptation efforts on the transportation system. Grant applications for competitive funds are due by October 20, 2017, and SCAG will also provide Caltrans with project descriptions for the programming of formula grant funds by this date. A draft of a formal amendment to SCAG's current Overall Work



Program, including scope(s) of work and timeline(s), will be submitted to Caltrans with the project descriptions by October 20th.

SCAG staff is working to develop the project descriptions that will be submitted to Caltrans by October 20th for the formula grant funds. SCAG is prioritizing projects that will benefit our member jurisdictions- such as additional funding for the Sustainability Planning Grant program and the Future Cities Initiative, as well as funding for other studies and planning projects to support the development of the 2020 Regional Transportation Plan/Sustainable Communities Strategy (RTP/SCS). Future SB 1 formula based funding for SCAG and other MPOs will be dependent on MPOs, like SCAG, to develop a SCS in the next planning cycle that continues to demonstrate meeting the SB 375 per capita GHG reduction targets established by the California Air Resources Board.

#### **EXECUTIVE SUMMARY:**

On August 17, 2017, the Mobile Source Air Pollution Reduction Review Committee (MSRC) approved the 2017/2018 Go Human Event Series. Attached is the project list and associated budgets for the \$5 million event series, which will be co-funded by SCAG and MSRC. The majority of projects selected for this cycle of the Go Human Event Series were submitted and evaluated through SCAG's 2016 Sustainability Planning Grant (SPG) Call for Proposals, which was approved by the Regional Council on February 2, 2017 and augmented with additional projects on April 6, 2017. To meet MSRC's per county funding minimums, several projects were added to the program following the adoption of the SPG and based on the host jurisdictions submittal of a letter of interest to SCAG. With the MSRC's approval of the 2017/2018 Go Human Event Series, SCAG may now commence with the planning and implementation of demonstration events.

#### **STRATEGIC PLAN:**

This item supports SCAG's Strategic Plan Goal 2: Obtain Regional Transportation Infrastructure Funding and Promote Legislative Solutions for Regional Planning Priorities; Objective 1: Identify new infrastructure funding opportunities with State, Federal and private partners.

#### **BACKGROUND:**

The 2016 Sustainability Planning Grants (SPG) Call for Proposals awarded grants and is providing support to a wide-range of projects focused on implementing the region's 2016 Regional Transportation Plan/Sustainable Communities Strategy. The SPG relies on several different funding sources, including a partnership with the Mobile Source Air Pollution Reduction Review Committee (MSRC) to support active transportation demonstration projects in the MSRC jurisdiction of Los Angeles, Orange, Riverside and San Bernardino counties. The MSRC's funding award was based upon SCAG's commitment to provide matching funds of at least an equivalent amount, and an agreement that each county within the MSRC's jurisdiction would receive a minimum of \$500,000 from the MSRC's investment.



SCAG has prepared a work program for the 2017/2018 Go Human Event Series that includes projects awarded through the SPG, as well as, new projects submitted through subsequent outreach by partnering agencies in order to meet MSRC's funding thresholds. The work program was approved by the MSRC on August 17, 2017, allowing SCAG to move forward in partnership with local agencies to implement the 2017/2018 Go Human Event Series.

The attached 2017/2018 Go Human Event Series includes a column highlighting the funding amount and source for each event. The MSRC's total funding commitment is \$2.5 million. SCAG will provide co-funding (matching funds) of an equivalent amount to projects, as noted in the attachment. SCAG's co-funding is provided from grant funding awarded to the agency by the Office of Traffic Safety for a complementary advertising campaign and from the California Active Transportation Program for event implementation. SCAG is also providing in-kind resources through the allocation of staff time to administer the work program.

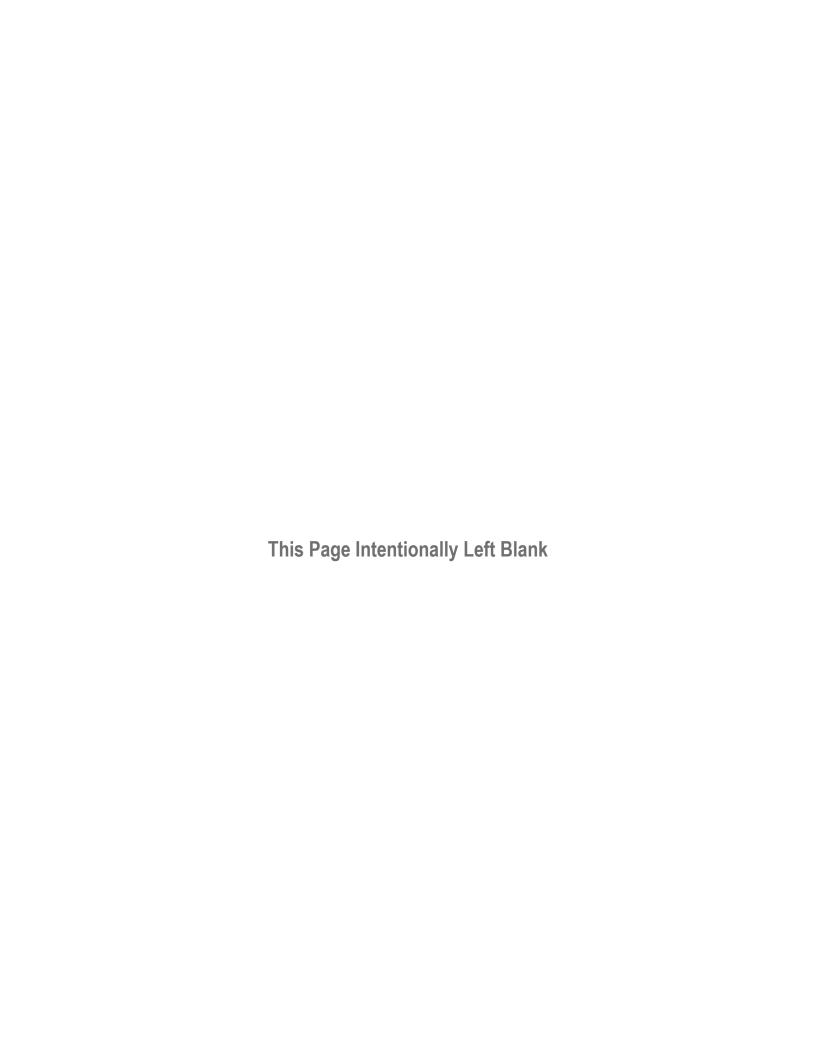

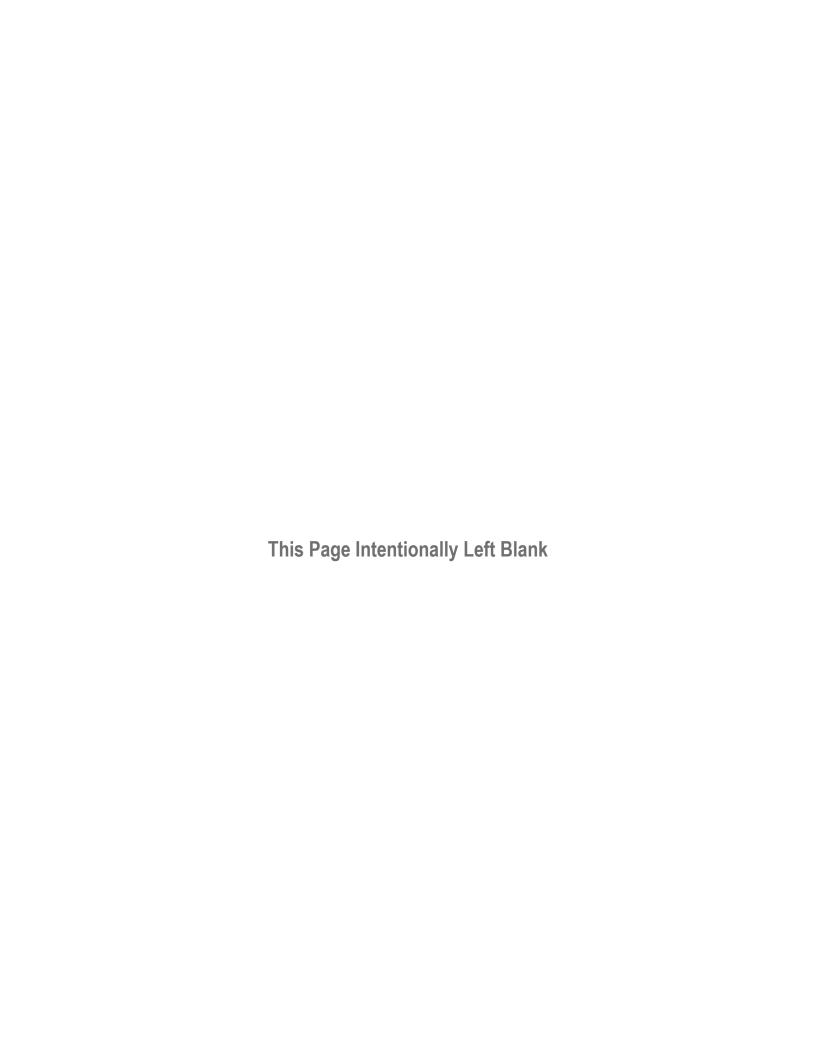

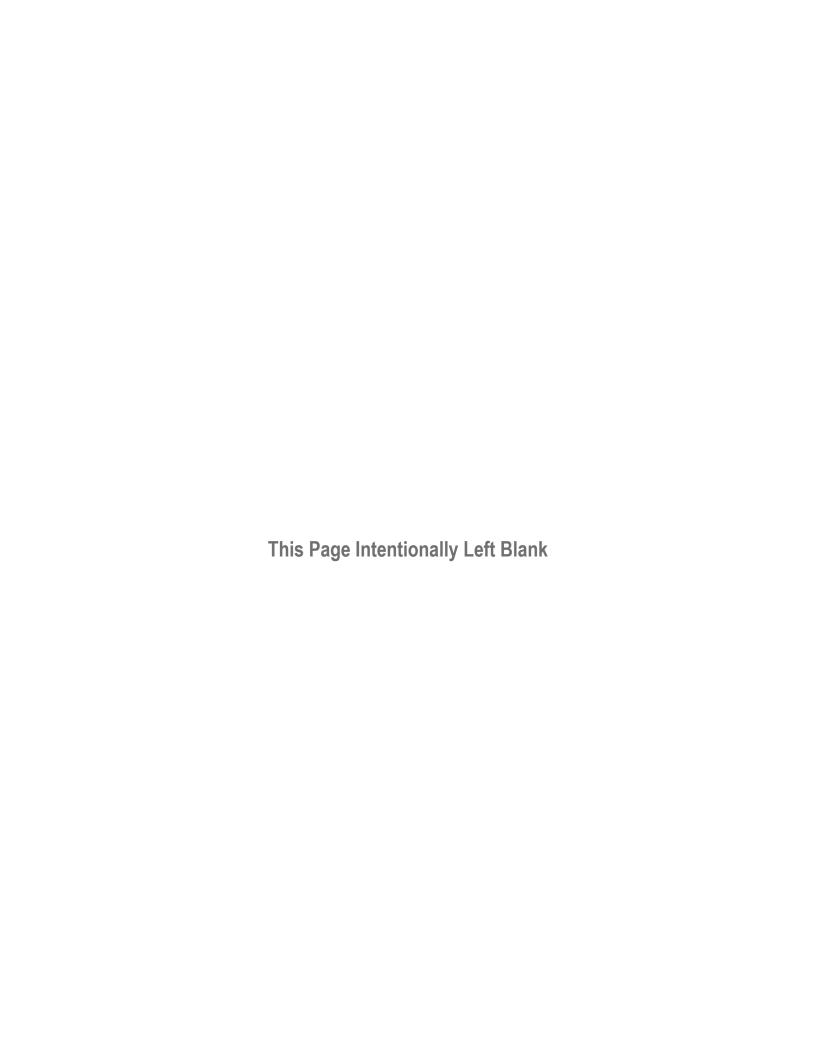

#### **EXECUTIVE SUMMARY:**

The Strategic Growth Council (SGC) has released the Notice of Funding Availability for the third round of the Affordable Housing Sustainable Communities (AHSC) program. AHSC funds the development of affordable housing and alternative transportation infrastructure through the Greenhouse Gas Reduction Fund (GGRF). SCAG has been providing capacity building support and technical assistance for the AHSC program since 2015. This year, SGC is funding technical assistance for several applicants across the state, which SCAG will supplement to provide support to additional applicants within our region. The due date for AHSC round three applications is January 15<sup>th</sup>, 2018.

#### STRATEGIC PLAN:

This item supports SCAG's Strategic Plan, Goal 1: Improve Regional Decision Making by Providing Leadership and Consensus Building on Key Plans and Policies: Objective a) Create and facilitate a collaborative and cooperative environment to produce forward thinking regional plans.

#### **BACKGROUND:**

The AHSC Program is a statewide competitive program to provide grants and loans for affordable housing, infill and compact transit-oriented development, and infrastructure connecting these projects to transit. This program is intended to further the regulatory purposes of AB 32 and SB 375 by investing ongoing Greenhouse Gas Reduction Fund (GGRF) appropriations in projects that achieve GHG and vehicle miles travelled (VMT) reductions and increase accessibility of housing and key destinations. The Strategic Growth Council and Department of Housing and Community Development (HCD) administer the program, including project evaluation and the approval of funding awards.



Through the first two funding rounds of the AHSC program, SGC has awarded over \$443 million to 58 projects across the state. In the SCAG region, 19 projects have been awarded a total of \$119 million and will build a combined 1,655 housing units.

During the last AHSC Round 2, SCAG partnered with SGC on the 2016-17 Technical Assistance Pilot which availed the region to nearly \$200 thousand in State resources to build capacity for competitive projects in future rounds. Staff leveraged the Pilot resources to provided technical assistance to 40 applicants and after the funding round closed, SCAG hosted nine (9) capacity building workshops to improve regional competitiveness for future rounds of funding.

#### Next Steps

For AHSC Round 3, SGC anticipates \$155 million of funding to be available for awards. SGC is also funding Technical Assistance to a limited number of potential applicants across the state. SCAG staff is coordinating with SGC on this effort and will be providing supplemental TA to eligible applicants in the SCAG region that did not receive state-funded technical assistance. Applications are due January 15, 2018 and award recommendations are anticipated to be announced in June 2018.

**SUBJECT:** The Governor's Housing Package and Implications for Local Jurisdictions

#### **EXECUTIVE SUMMARY:**

In response to the ongoing California housing crisis, over one hundred (100) bills related to housing have been proposed in the State Legislature. Of these bills, three (3) of them form the backbone of the Governor's Housing Package, which is intended to bring more funding to local jurisdictions to build more housing and streamline the local development process.

#### STRATEGIC PLAN:

This item supports SCAG's Strategic Plan; Goal 1: Improve Regional Decision Making by Providing Leadership and Consensus Building on Key Plans and Policies; Objective A: Create and facilitate a collaborative and cooperative environment to produce forward thinking regional plans.

#### **BACKGROUND:**

Over one hundred (100) housing-related bills have been proposed during the 2017-2018 California State Legislative session. The goal of many of these bills has been to address the housing crisis through a variety of means, including establishing a permanent source of funding for local development, streamlining the permitting process, increasing homeless assistance, and encouraging certain zoning designations. Of these proposed legislation, three (3) bills, Senate Bill 2 (Atkins), Senate Bill 3 (Beall), and Senate Bill 35 (Weiner), have been designated as the backbone of Governor Brown's Housing Package. The Housing Package was a result of intense negotiations among lawmakers and stakeholders over the last several weeks and is aimed at generating billions of dollars for affordable housing and homeless assistance as well as efforts to streamline the local development process.

#### Senate Bill (SB) 2 (Atkins): Building Homes and Jobs Act

SB 2, also known as the "Building Homes and Jobs Act," would assess a \$75 fee on real estate recorded documents, excluding those documents associated with real estate sales. Transactions involving the sale of commercial and residential real estate are exempt from the fee. For fees collected in 2018, fifty percent (50%) would be distributed directly to local governments to address local needs while the remainder will be allocated by the California Department of Housing and Community Development (HCD) on a competitive basis. For fees collected in 2019 and thereafter, seventy percent (70%) would be deposited into a fund specifically for local governments while thirty percent (30%) would be allocated to HCD for specified purposes, including a continuous appropriation of moneys to the California Housing Finance Agency for the purpose of creating mixed income multifamily residential



housing for lower to moderate income households. SB 2 also requires that twenty percent (20%) of all funds collected be expended for affordable owner-occupied workforce housing and that funds allocated to jurisdictions be used to support affordable housing, home ownership opportunities, and other housing-related programs.

Similar legislation proposing a permanent source of funding for affordable housing through real estate transaction fees have been proposed previously in the State Legislature but have not gained enough votes for passage. SB 2 passed the State Senate and was referred to the State Assembly in early July. At the time of this staff report's writing, SB 2 passed the House by a vote of 27-11 and is waiting for the Governor's signature.

#### Impact to Local Jurisdictions

Jurisdictions would greatly benefit from a permanent source of funding dedicated toward building affordable housing. Subsequent to the statewide dissolution of redevelopment agencies in 2012, jurisdictions have been struggling to increase the supply of affordable housing at the local level. Also beneficial to jurisdictions is the increase in the percentage of funds from 50 to 70% beginning from the second year of the fund. It has been estimated that \$250 million will be collected statewide annually from the fee.

#### Senate Bill (SB) 3 (Beall): Veterans and Affordable Housing Bond Act

SB 3 would enact the "Veterans and Affordable Housing Bond Act", which if adopted by California voters at the November 8, 2018 general election, would authorize a \$4 billion bond issuance to finance various existing housing programs as well as infill infrastructure financing and affordable housing matching grant programs. Of the proceeds from the sale of these bonds, \$3 billion would be used to finance various existing housing programs, as well as infill infrastructure financing and affordable housing matching grant programs. The remainder \$1 billion from bond proceeds would be used to provide additional funding for farm, home, and mobile home purchase assistance for veterans.

In November 2006, California voters approved Proposition 1C, which originated as SB 1689 (Perata) passed in May 2006. Proposition 1C invested \$2.85 billion for housing and infrastructure programs to produce an estimated 118,000 housing units, 2,350 homeless shelter spaces, and infrastructure projects. Proposition 1C funds were available until last year, in which HCD issued its last Notice of Funding Availability (NOFA) for its Housing-related Parks Program grant.

At the time of this staff report's writing, SB 2 passed the House by a vote of 30-8 and is waiting for the Governor's signature.

#### Impact to Local Jurisdictions

SB 3 has the potential to greatly benefit jurisdictions in that it would create a permanent source of funding dedicated to building affordable housing. Rather than allocating funds directly toward local jurisdictions, bond funds would be administered through state agencies such as HCD. It is possible that these funds will be administered through various grants, both competitive and guaranteed, similar to Proposition 1C funds, which encourage and facilitate affordable housing. Although local jurisdictions will not receive direct funding, SB 3 would create more options and incentives for funding sources to encourage the building and permitting of housing at the local level.



#### Senate Bill (SB) 35 (Weiner)

SB 35 would require multi-family housing developments that meet certain specific planning objectives, such as infill location and a certain percentage of affordable units, to be subject to a streamlined, ministerial approval process by a jurisdiction. This bill would also limit the authority of a jurisdiction to impose parking requirements on projects that qualify for the streamlined process. This process would apply in jurisdictions where an insufficient number of permits have been issued as reported in their respective annual progress report to the California Department of Housing and Community Development (HCD), which reports building activity in comparison to the Regional Housing Needs Assessment (RHNA) allocation.

At its September 7, 2017 meeting, the Regional Council approved the Legislative, Communications & Membership Committee's (LCMC) recommendation from its August 15, 2017 meeting for SCAG to formally adopt an "Oppose Unless Amended" position on SB 35. While the Regional Council and LCMC recognized that SCAG's adopted legislative priorities and housing principles include supporting proposals that seek additional funding and resources to address California's shortage of housing and affordable housing, it was their belief that this bill does not constructively resolve this problem. As part of their "Oppose Unless Amended" position, RC and LCMC members expressed several points of concern with SB 35 and proposed several amendments, including removing the bill's prevailing wage requirements, adding local discretion on parking requirements, ensuring environmental protection if CEQA is streamlined, and not eliminating the public comment process.

At the time of this staff report's writing, SB 2 passed the House by a vote of 23-14 and is waiting for the Governor's signature.

#### Impact to Local Jurisdictions

Unlike SB 2 and SB 3, SB 35 aims to increase the supply of housing at the jurisdictional level through the planning and zoning process. While aimed at reducing costly delays and uncertainty of project approval, SB 35 also reduces the level of local decision-making in certain situations in an effort to increase the supply of housing. If a project qualifies for streamlined approval, the approval process at the jurisdictional level can only be ministerial and there are no further opportunities for public input. To prevent this situation, a jurisdiction must have permitted enough units in the proposed project's targeted income category by the time the project is proposed. A checklist of requirements for the streamlined approval process will be provided at the October 5 CEHD Committee meeting.

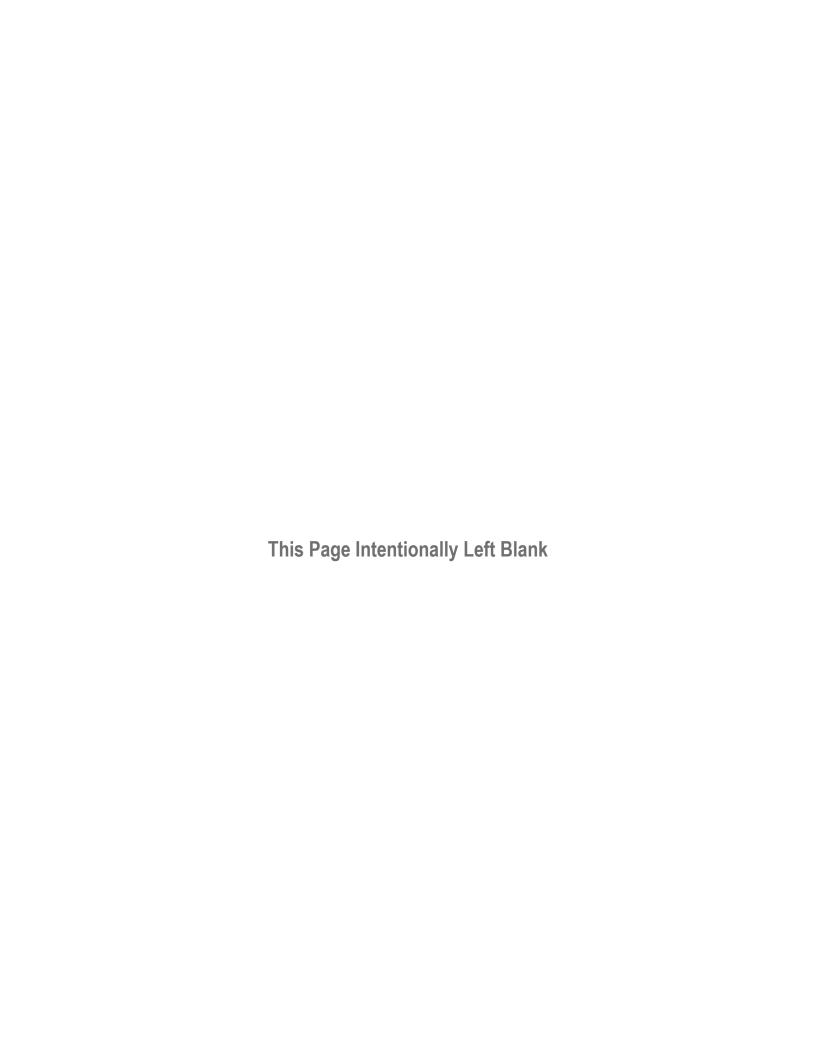

### **Governor's Housing Package**

- Over 100 bills were proposed as part of this year's legislative session
- Governor has until October 15 to sign
- Senate Bill 2 (Atkins)
- SB 3 (Beall)
- SB 35 (Weiner)

# SB 2 (Atkins) Building Homes and Jobs Act

- Assesses a \$75 fee on all real estate transactions except for residential sale
- Expected to raise \$250 million statewide
- Fees collected in 2018:
  - 50% will go to local governments
  - Remainder will go to HCD for grant programs
- Fees collected in 2019 and beyond:
  - 70% will go to local governments
  - Remainder will go to HCD for programs and affordable housing fund

### SB 3 (Beall)

### **Veterans and Affordable Housing Bond Act**

- Authorizes a \$4 billion bond ballot measure in November 2018
- \$3 billion would finance existing housing programs, \$1 billion set aside for veteran housing assistance
- Similar to Proposition 1C (2006)

### SB 35 (Weiner)

- Focuses on local supply side of housing crisis
- Basis in the Governor's "by-right" proposal in last year's Statewide budget

### SB 35 (Weiner)

### -Ministerial Approval Process

- By-right
- A project must meet several criteria before qualifying, including:
  - Urbanized area
  - Zoned for residential or multi-use residential
  - Not in protected areas (e.g. coastal, prime farmland, hazardous waste site, etc)
  - Cannot require demolition of occupied units or historic structures

### SB 35 (Weiner)

### -Ministerial Approval Process

- If a jurisdiction has not met its above moderate housing need, at least 10% of the project units must be set aside for affordable housing
- If a jurisdiction has not met its affordable housing need, at least 50% of the project units must be set aside for affordable housing

# SB 35 (Weiner) -Parking Requirement Limitations

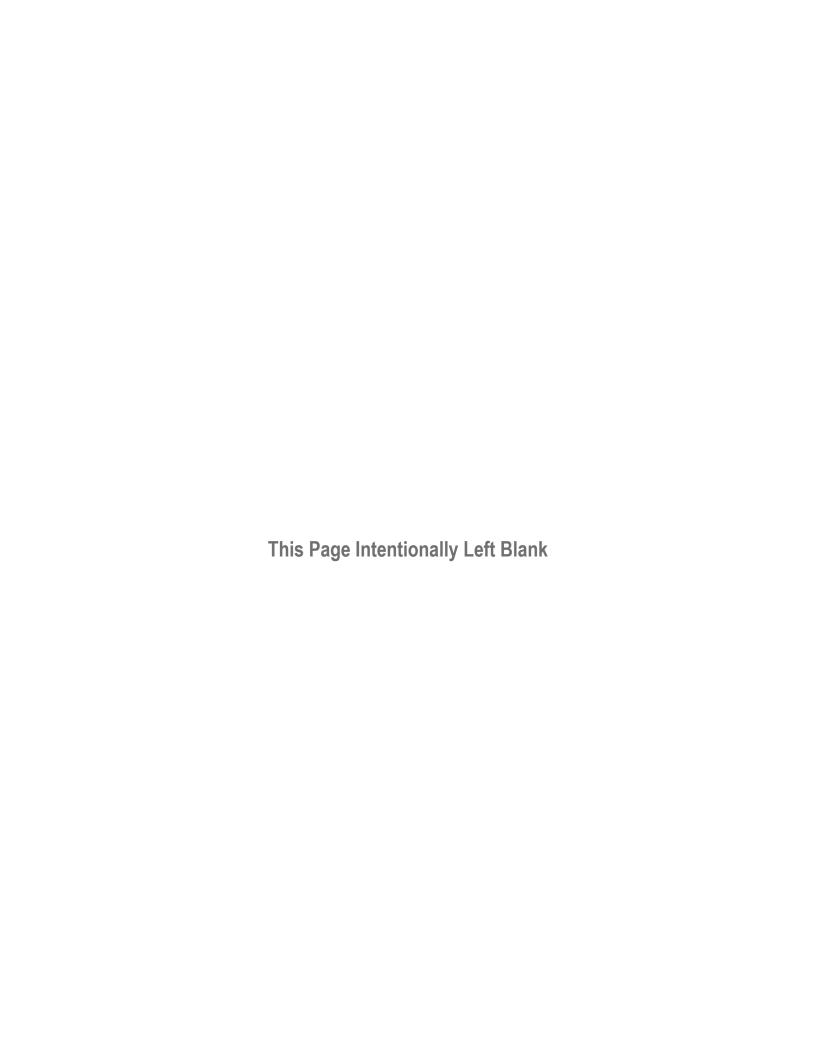
- Parking standards cannot be imposed if:
  - Project is located within ½ mile of public transit; or
  - Project is located in a historic district; or
  - On-street parking permits are required; or
  - There is a car share vehicle within one block
- Maximum ratio for streamlined projects
  - 1 space : 1 unit

#### **EXECUTIVE SUMMARY:**

As a result of lack of housing supply and affordability, the housing crisis has reached critical levels with impacts felt across California. To address the crisis locally, a growing number of local housing advocacy groups have formed to encourage housing development for all segments of the population, also known as "YIMBY" groups. Brian Hanlon, Co-founder of California YIMBY, will present to the CEHD Policy Committee on the housing crisis and how YIMBY groups are beneficial as a local strategy to address the crisis. Additionally, Chelsea Byers, Director of Organizing of Abundant Housing LA, a YIMBY group based in the City of Los Angeles, will also present on the membership of Abundant Housing LA and who and what make up the YIMBY movement.

#### **STRATEGIC PLAN:**

This item supports SCAG's Strategic Plan; Goal 1: Improve Regional Decision Making by Providing Leadership and Consensus Building on Key Plans and Policies; Objective A: Create and facilitate a collaborative and cooperative environment to produce forward thinking regional plans.

#### **BACKGROUND:**

California is facing a statewide housing crisis due to a combination of both a housing shortage and a lack of affordability, and the problem is not limited to housing for low-income families. From 2000 to 2014, the median rent in California increased by 28% while the median household income dropped by 8%. The median home price in California is now over \$460,000 and is over two and a half times the national average. Low income families are particularly hard hit and more than 60% of very low income families spend over half their income on housing costs.

In October 2016, SCAG and over thirty-five (35) partners hosted a statewide Housing Summit, which looked at different impacts of the housing crisis and potential strategies to address it. One of the strategies was to encourage the formation of local YIMBY groups, which are community-led groups that advocate for housing for multiple or all segments of the population and are not necessarily limited to housing for low income families.



Brian Hanlon, Co-founder of California YIMBY will present to the CEHD Policy Committee on the housing crisis and how YIMBY groups are beneficial as a local strategy to address the crisis. California YIMBY is a recently formed Sacramento-based advocacy organization that aims to solve the housing shortage by passing laws to double the rate of home building in California. The organization works closely with local YIMBY groups to empower grassroots activists to demand that their elected officials support pro-housing solutions.

Additionally, Chelsea Byers, Director of Organizing for Abundant Housing LA, will also present to the CEHD Policy Committee on the membership of Abundant Housing LA and who and what make up the YIMBY movement. Abundant Housing LA is a Los Angeles-based group whose mission is to advocate for housing for all incomes and to create a sustainable and prosperous region.
