### 3. HELPR WEB MAPPING APPLICATION PROPOSED UPDATES





## **Open discussion on Connect SoCal 2024 process**

*July 18, 2024 Technical Working Group meeting*

*The purpose of this discussion on Connect SoCal 2024 is to inform the planning and preparation for the next plan development cycle. SCAG is also conducting internal review of plan development activities and stakeholder engagement. We are not committing to any specific activities, actions or timelines for the 2028 RTP/SCS.*

1. Initial reflections: What went well and should be continued in the next cycle? What could be improved for the next cycle?
2. The following is a list of plan related items that came before the TWG in the years leading up to the draft and final plan release:
  - a. Local Data Exchange and Forecasted Regional Development Pattern
  - b. Performance Measures
  - c. Equity Analysis
  - d. CARB/Sustainable Communities Strategy
  - e. PEIR
  - f. Other programs (Greenprint, Regional Resilience Framework)

SCAG also often briefed this group about upcoming Policy Committee agenda items, such as the Joint Policy Committee presentations.

- Are there other aspects of plan development that would have benefited from review by TWG?
  - Was there content presented to the TWG that was not useful or relevant?
3. Comment Process: Did participation in the TWG help with the public comment period? Why or why not?
  4. Meeting logistics: Generally, the TWG met every other month, remotely. Based on previous feedback, staff aimed to leave ample time for discussion or questions with each agenda item. Is there any feedback or considerations that we should make for this group going forward: time of day, duration, frequency, meeting format, etc.?
  5. Final reflection: If you could change one thing about the process to enhance participation/communication, what would it be and why?
